1. Course Booking & Payment

A course place is only secured once full payment or an agreed deposit has been received. All course fees must be paid in full before the course start date unless otherwise agreed in writing.

2. Refunds, Cancellations & Transfers

3. Course Dates & Venue

4. Attendance & Punctuality

5. Learner Conduct
